## Port of Pittsburgh Commission Report

Jim McCarville presented the following information:

- Special thanks were extended to WAP members for all the support provided to Jim during his tenure as the Port's Executive Director. The Association's partnership between companies and federal agencies is a unique characteristics not found in any other area.

- The President did sign the WRDA bill yesterday and the success for this passage illustrates the perseverance of our members to bring waterway issues to the forefront. However, there is still much work to be done. The gas tax increase that will generate replenishment to the Inland Waterways Trust fund needs to be addressed. Challenges continue with hours of operation along with Upper Ohio issues. The Army Corp of Engineers establishment of maintenance priorities continue to improve. The Wireless Waterways project is a cutting edge program to improve efficiency on the waterways.
- Members were invited to attend the June 18th reception in conjunction with our Second Annual Interoperability Test Bed Symposium. Eleven companies will be presenting their latest products and testing them on the Wireless Waterway system. They will be demonstrating cutting edge technology in Maritime Safety, Security, Environment and Transportation. The reception will be held in the Reception Tent located at the Carnegie Science Center/River Side/North Shore beginning at 4 p.m. - 7 p.m.

#### **Education Committee Report**
