## LEGISLATIVE COMMITTEE:

### 1. Priorities:

- Continue to support Upper Ohio River Navigation System & Lower Mon Projects
- Oppose additional taxation, tolling, and lockage fees
- Fully utilize and draw down funding from the Inland Waterways Trust Fund
- 2. Congressional Appropriations
  - Request submitted for additional funding needed for the Lower Mon Project
- 3. Water Resources Development Act of 2024 time to start preparing for next WRDA
  - WRDA addresses water infrastructure needs critical for the Nation's economic competitiveness and domestic security. WRDA is strictly authorizing legislation. The funding to implement authorized studies, projects, and activities is provided separately through the annual appropriations budgetary process.

# PORT OF PITTSBURGH COMMISSION:

- 1. Grant funding opportunities
  - PortPitt's Senator Jim Ferlo Memorial Small Grants Program (closed)
  - The Federal Highway Administration is accepting applications for the **Reduction of Truck Emissions at Port Facilities Grant Program** (open – due 7/26)
  - PA DCED Multimodal Transportation Fund (open due 7/31)
- 2. United States Marine Highway Program Application is pending and being reviewed by USDOT
  - Expect decision mid-July
- 3. Past Events
  - Pittsburgh Traffic Club hosted tour of both PennDOT's Traffic Management Center and the Fort Pitt Tunnel on Wednesday, June 27<sup>th</sup>
  - **On June 28<sup>th</sup>**, **PortPitt's** media consultant **did a video shoot** on our rivers along with both the PA Fish & Boat Commission and Campbell Transportation Company, Inc., related to recreational boater interaction with commercial vessels.
  - The PA Fish and Boat Commission, in partnership with NASBLA (National Association of State Boating Law Administrators) and partnering agencies and organizations held a media event on June 29<sup>th</sup> in Pittsburgh in advance of Independence Day that was the national kickoff for "Operation Dry Water", a nationwide effort to educate the public about the danger of Boating Under the Influence (BUI).
