SUBJECT: Items of Interest to Navigation, August 13, 2014

1. LOCK CLOSURES AND DELAYS

Ohio River

- **Dashields L/D** - The USACE Repair Fleet mobilized to conduct phase 2 work of the lock closure system in the primary 110-ft x 600-ft land lock chamber on 11 August 2014. The chamber is expected to be out of service until 19 September 2014 (33 days). Reference Navigation Notice 14-17.
- **Montgomery L/D** - The USACE Repair Fleet (Huntington District) is scheduled to begin downstream miter gate repairs in the primary 110-ft x 600-ft river lock chamber on 18 August 2014. The chamber is expected to be out of service until 05 September 2014 (18 days). Reference Navigation Notice 14-18.

Monongahela River

- **Maxwell L/D** - The river lock chamber at Maxwell L/D is out of service until further notice. This unscheduled lock closure is the result of a navigation accident that happened early Thursday morning on October 31, 2013. Reference: Navigation Notice 13-43.

Allegheny River

- **L/D 5** – Resumed LoS 2 operations beginning the week of 11 August 2014. Service will be 2 shifts, 7 days per week, available from the hours of 0700 thru 2300. Reference: Navigation Notice 14-31 (Rev 1).

2. OTHER ITEMS OF INTEREST

- Dane P. Summerville has been selected as Supervisory Operations Specialist for the Allegheny River. He will assume the duties of the position effective 10 August 2014.
- LTC Gerald Dull assumed the duties of Deputy Commander effective 28 July 2014
- HQUSACE "listening sessions" on the WRRDA of 2014 begin today at 1400
- LRD Regional Command Council (RCC) will meet in Pittsburgh on 21 and 22 August 2014 and will tour the work at Montgomery on the 21st.
- The new IMTS Levels of Staffing OORDER has been released and is expected to take effect by the end of the year.
